The company's lead programme fimaVACC aims to enhance immunotherapy in cancer, by triggered endosomal release of antigens or nucleic acids encoding antigens, or immunostimulatory factors. Enhancement of relevant immune responses with protein- and peptide-based vaccines were successfully demonstrated in humans through a Phase I study in healthy subjects and a Phase II study is in planning with the aim to demonstrate enhancement of immunotherapy for treatment of solid tumours. In the fimaVAC programme endosomal release is utilised to provide intracellular delivery of nucleic acids, such as mRNA and RNAi therapeutics, thereby addressing one of the major bottlenecks facing this emerging and promising field.

PCI Biotech is a clinical stage biopharmaceutical company with an international team of about 13 employees, with offices at Oslo Cancer Cluster Innovation Park in Oslo, Norway. The company is listed on the Oslo Børs under the ticker PCIB.
